Roland Barthes is a central figure in the study of language, literature, culture and the media, both as innovator and guide. This book prepares readers for their first encounter with his crucial writings on some of the most important theoretical debates of the 20th century, including: existentialism and Marxism; semiology, or the language of signs; structuralism and

Istanbul

Systemic Governance and Accountability

Robert Browning was one of the greatest of English poets, whose intense and original imagination enabled him to transform any subject he chose - whether everyday or sublime - into startling memorable verse. In his work he brought to life the personalities of a diverse range of characters, and introduced a new immediacy, colloquial energy and psychological complexity to the poetry of his day. The volume contributors are experts from linguistics, communication studies, rhetoric, literary analysis, document design, sociolinguistics, education, ethnography, and cultural psychology, and each utilizes a specific mode of text analysis. Harold Bloom

This collection explores and clarifies two of the most contested ideas in literary theory - influence and intertextuality. The study of influence tends to centre on major authors and canonical works, identifying prior documents as sources or contexts for a given

author. Intertextuality, on the other hand, is a concept unconcerned with authors as individuals; it treats all texts as part of a network of discourse that includes culture, history and social practices as well as other literary works. Shelley's Frankenstein
